Utility Superintendent Earl Heide reported Peerless will be checking water plant pump

Utility Superintendent Earl Heide reported a 4" water line leak has been repaired

Utility Superintendent Earl Heide reported Wastewater ditch area very muddy and has created muddy streets and contractors are working to enter and exit same route to limit muddy areas. Wastewater plant generator cement pad is ready and fence will be moved, and plans are made in preparing for issues with manhole areas occur. Town Board Member Paul Buckles raised concern of street wear and tear with the additional heavy equipment traffic

Utility Superintendent Earl Heide reported new wastewater and water service lines at resident Paul Buckles purchased lot location 826 Linden Blvd will be crossing street area and neighbor property due to the location of the main lines. Busse's Excavating owner Jay presented information on the boring process to preserve the street area from damage.

Town Marshal Mike Taylor reported west side South Street speed sign has arrived and will be installed

Town Board President Wade Bennett asked how the Flock is working. Town Marshal Mike Taylor reported Flock is working, and have been able to work with multiple law enforcement departments
