

Linden Town Board Meeting August 25 2020

Roll Call: Town Board Members Wade Bennett, Paul Buckles, Dennis Charleston, Clerk/Treasurer Janet Heide present

Town of Linden Board meeting called to order by Town Board President Wade Bennett at 7:04pm

Town Board President Wade Bennett read aloud park meeting list. After discussion, Board agreed Town Board Member Paul Buckles will contact local painter for painting quote, Park Caretaker Earl Heide will order green bouncy, and Street Superintendent Earl Heide will contact Fox Paving for Park Path quote

Town Marshal Brian Riehle expressed concerns of possible accidents and will collect information and forward to board members
