Roll Call: Town Board Members Wade Bennett, Paul Buckles, Dennis Charleston, Clerk/Treasurer Janet Heide present

Town of Linden Board meeting called to order by Town Board President Wade Bennett at 7:04pm

Town Board Member Paul Buckles made a motion to elect Town Board Member Wade Bennett as 2021 Board President. Town Board Member Dennis Charleston 2nd motion; Town Board Member Wade Bennett called for vote, motion carries

Town Board President Wade Bennett presented 2021 AWL contract and invoice. After Board discussion Town Board Member Paul Buckles made a motion to sign and accept 2021 AWL contract and invoice; Town Board Member Dennis Charleston 2nd motion. Town Board President Wade Bennett called for a vote, motion carries.

Town Board President Wade Bennett presented eGov quote to update website cost \$7,500.00. After Board discussion; Town Board Member Paul Buckles made a motion not to sign and accept eGov quote; Town Board Member Dennis Charleston 2nd motion. Town Board President Wade Bennett called for a vote, motion carries.

Town Board President Wade Bennett presented 2 claims for payment to complete street grant project as follows \$27,317.58 holdback, \$2,457.00, \$over bid line cost paying Midwest Paving. After Board discussion; Town Board Member Paul Buckles made a motion to pay claims to Midwest Paving; Town Board Member Dennis Charleston 2nd motion. Utility Superintendent Earl Heide reported County Ditch project east of water plant has placed drainage inside fenced area and request drainage project. After discussion, Board agreed to 2021 Storm Water East District Project to help in the removal of standing water at water plant and surrounding ditch area

Town Board President Wade Bennett read aloud and presented monthly police department report for board signature.

Town Marshal Brian Riehle reported Deputy King has received a promotion within the Sheriff Department and will continue working as Deputy Marshal for the Town of Linden

Town Board Member Paul Buckles requested update on Linden sign project of any contribution from Church. Town Board President Wade Bennett has not heard from the church or Jessica. Clerk/Treasurer Janet Heide requested to appropriate funds so sign project can proceed. Board agreed 4 Town of Linden signs and approves up to \$1,000 of general fund budget toward Linden sign project.
