Brian Butler with K&R Water reported IDEM inspection findings and requested to meet with Board Members before responding to IDEM written report. Board Members agreed and Town Board Member Wade Bennett will construct letter for Water Street and South Street property owners of Wastewater project. Town Board Members agreed to have attorney update illegal wastewater hookup Ordinance

Linden Utility Superintendent Earl Heide reported smoke testing starting Wednesday and will take engineer to wastewater plant for UV light project recommendations

Linden Utility Superintendent Earl Heide reported Tower project underway, tower is drained and bladder tank is working; an additional cost of a broken valve repair will be approximately \$5,000.00

Linden Park Superintendent Earl Heide reported Park project complete and grass growing. Town Board Member Paul Buckles asked status of park restrooms. Linden Park Superintendent Earl Heide reported tower crew is using one restroom and using other for equipment storage

Town resident Deb Fagan stated property at 220 Harding Street is cleaned up. Town Marshal Brian Riehle reported working with property owners to clean up properties around town

Town resident Larry Miller asked about status of 414 Water Street. Town Marshal Brian Riehle reported working on this property
