

Linden Town Board Regular Meeting Minutes September 24 2019 @ Town Hall meeting room

Roll Call: Town Board Members Wade Bennett, Paul Buckles and Clerk/Treasurer Janet Heide present; Town Board Member Andrew Traylor absent

Town of Linden Board meeting called to order by Town Board President Wade Bennett at 7:06pm

Town Resident Steve Struck discussed issues with 202 South Harrison Street tree on house and 314 West Walnut Street vehicle on property. Town Marshal Brian Riehle updated 202 S Harrison St is in the nuisance ordinance processes and will look into vehicle violation

Town Resident Larry Miller asked to clarify rules of a tax sale property. Town Resident John King asked if town cost can still be collected on mowing. Town Board President Wade Bennett stated nothing can be changed for one year by new owner and town can still lien property if ordinance violation occurs.

Town Marshal Brian Riehle stated police department has equipment to destroy and will compile a list of the equipment

Town Deputy Marshal Travis King reported bank robbery investigation is moving forward and working with other agencies

Town Board Member Paul Buckles asked if police department will enforce new speed without signs up. Town Marshal Brian Riehle stated will not write ticket with signs. Clerk/Treasurer Janet Heide stated Ordinance 2019-1 has been posted and advertised since August.
