

Linden Town Board Meeting November 17 2020

Roll Call: Town Board Members Wade Bennett, Paul Buckles, Dennis Charleston, Clerk/Treasurer Janet Heide present

Town of Linden Board meeting called to order by Town Board President Wade Bennett at 7:00pm

Water Superintendent Earl Heide reported continued work on replacing fire hydrants project

Town Board Member Paul Buckles asked who pays for siren cost. Clerk/Treasurer Janet Heide reported cost are paid by Town general fund

Town Board Member Paul Buckles asked about fire department Halloween night activities. Fire Chief Earl Heide reported passed out candy at table located in bay door area with no entrance to public and had less crowd than prior years

Fire Chief Earl Heide reported making plans for a Saturday in December to have a Fire Truck and the Town Police car drive Santa and Grinch around town with no contact or candy

Town Marshal Brian Riehle presented monthly report for board signature
