Town of Linden regular monthly meeting called to order by Town Board President Wade Bennett at 7:00pm

Town Board President Wade Bennett presented Resolution 2023-2 for public hearing and adoption, and read aloud, no public comment, Town Board Member Paul Buckles to adopt Resolution 2023-2, Town Board Member Dennis J. Charleston 2nd motion; Town Board President Wade Bennett called for a vote, motion carries

Mary Broadstreet reported Splash Pad Committee has added 2 new members, and working on combining Friends of Linden with Splash Pad Committee and to create the Town Parks into a 501C nonprofit creating a donation fund for all activities. Resident Steve Struck inquired if gas service line upgrades will include west side homes. Town Board President Wade Bennett reported no information has been received on other Town areas upgrades.

Resident Steve Struck inquired if the US231 project will include a by-pass around Town. Town Board President Wade Bennett reported project US231 widening is North and South of Town

Resident Steve Struck suggested paint wide white lines at the 4 way stop intersections

Resident Carla Brady asked what the Town Marshal hours are, Town Board President Wade Bennett stated police department works 10 hours weekly, all residents always have the available options to contact Town Marshall by posting message to Linden Police facebook page, leave message by calling office phone, send email message and calling County Dispatch
